Adobe Foundation (the “Foundation”) appreciates your willingness to grant the Foundation permission to use your all of your works of authorship and other materials developed in connection with the Adobe Youth Voices program (“Materials”).

By signing this letter (“Agreement”), you grant the Foundation and anyone authorized by the Foundation the irrevocable and perpetual right to use, modify, create derivative works therefrom, reproduce, publicly perform and display, transmit, translate and distribute (through multiple tiers) the Materials, in any medium of expression (including social media properties) existing now or developed in the future for or in connection with the Adobe Youth Voices program, the Foundation and the charitable purposes of the Foundation, without further approval by or payment to you (the “License”). In the event that any of the Materials are not deemed to be licensed to the Foundation under this Agreement at the time of their creation, you agree to execute the necessary documents to license such Materials to the Foundation.

The License is nonexclusive, worldwide, royalty-free and fully paid. You will retain ownership of the Materials. If the Materials contain music, the License also includes (a) the copyright of the musical composition, including the composition and the lyrics; (b) the reproduction rights, including any synchronization rights, mechanical rights and/or master rights; (c) the public and/or digital performing rights; and (d) the adaptation rights.

The Foundation agrees that it will take reasonable steps to protect the Materials to the same extent it would protect its own materials. You in turn represent to the Foundation that, as the sole owner of the Materials, you have full rights to grant the License of the Materials to the Foundation.

This Agreement is the entire agreement between you and the Foundation with respect to the License. It supersedes any similar prior agreements, and may only be amended in a writing signed by both you and the Foundation. You agree that this Agreement shall be governed by the laws of the State of California, excluding any of its conflict of laws provisions, and you consent to the exclusive jurisdiction and venue in the State and Federal Courts of Santa Clara County in the State of California.
